NOW, THEREFORE, THIS GRANT OF EASEMENT WITNESSETH: That for and in consideration of the above premises, One Dollar (\$1.00) and other good and valuable considerations, the receipt whereof is hereby acknowledged, Grantors do hereby grant unto the <u>STATE OF MARYLAND, TO THE USE OF THE STATE HIGHWAY ADMINISTRATION OF THE MARYLAND DEPARTMENT OF TRANSPORTATION</u>, its successors and assigns, the right to create, use and maintain on the area of the land, containing 5,986 square feet or 0.137 of an acre of land, more or less, and shown

hatched thus on State Highway Administration Plat numbered 59981, such slopes as are necessary to retain and support the highway and/or adjacent property; it being agreed between the parties hereto, however, that at such time as the contour of the land over which this slope easement is granted is changed so that the easement required for slopes is no longer necessary to retain, support or protect the highway construction within the area conveyed in fee simple, then said easement for slopes shall cease to exist.

TO HAVE AND TO HOLD the easements, rights and/or controls above described and mentioned and hereby intended to be granted unto the proper use and benefit of the State of Maryland, to the use of the State Highway Administration of the Maryland Department of Transportation, its successors and assigns, together with the privileges and controls hereinbefore mentioned.

AND Grantors covenant that they have neither done, nor suffered to be done, anything to encumber the easements, rights and/or controls hereby granted and that they will execute such other and further assurance of same as may be requisite and will specially warrant the herein * granted easements, rights and/or controls.
