



NOTES

1. Bold lines indicate structural wall or the walls constituting unit boundaries. Not all interior walls within the units are shown hereon. "Unit" or "unit" means a three-dimensional area as described and defined in the declaration and the Act.
2. Upper and lower elevations of each unit are based on W.S.S.C. datum. A typical example of the average lower elevation for a unit is 76.10'. A typical example of the average upper elevation for a unit is 84.22'. A typical example of the peak elevation of a unit is 88.37'. The upper elevation of a unit may vary according to the slope of the ceiling of such unit \pm 60 degrees from the peak elevation. Upper elevation for the second floor units do not include the vaulted ceiling elevations (see detail above).
3. The floor area of each unit is shown in square feet. A typical example is 970.
4. Each unit shown hereon is depicted by a number. A typical example is 2-5
