AMENDMENT OF DECLARATION AND BY-LAWS

FOR

ASPEN MILL PROFESSIONAL CONDOMINIUMS

WHEREAS, the Undersigned are all the owners and mortgagees (or trustees under a Deed of Trust) of all the Units in Aspen Mill Professional Condominiums.

WHEREAS, the undersigned desire to Amend the Declaration and By-Laws dated April 15, 1983 and recorded among the Land Records of Baltimore County in Liber E.H.K.Jr. No. 6513, folio 386, etc. as hereinafter set forth pursuant to the provisions of said Declaration and By-Laws and in compliance with the Condominium Act Title 11 Sections 103 and 104 of the Real Property Article of the Annotated Code of Maryland, 1974 Edition as amended.

NOW, THEREFORE, the Undersigned, being all of the Unit Owners and Mortgagees (including Trustees under Deeds of Trust) and pursuant to the provisions of said Declaration and By-Laws, and in compliance with said Condominium Act, as amended, hereby make the following Amendments:

1. Amend Article III Section 1 (e) of the Declaration to read as 8 30/F follows: SELAR. 517 TA T (e) The entrance doors and windows to each unit, equipment and - 113 Add TIANO appurtenances located within any unit or located in or on any common element and designed to serve only that unit, such as furnaces, and air-conditioning equipment, and thermostats controlling same, mechanical equipment, appliances, range hoods, non-bearing partition walls, flooring material, outlets, electrical receptable and outlets, fixtures, cabinets and the like, shall be considered a part of the condominium unit and not a part of the common elements.

Amend Article IV Section 2 of the By-Laws to read as follows:

Section 2. Annual Meetings. The Organizational and First Meeting of the Council of the Condominium shall be held within sixty (60) days after eighty per cent (80%) of the units in the Condominium Regime as then constituted have been sold and title to the same has been conveyed, or on the second Wednesday of November, 1984, whichever shall first occur. Thereafter, annual meetings of the Council of the condominium shall be held on the second Wednesday of November of each succeeding year and all such meetings shall be conducted in the evening hours. At such meeting there shall be elected by ballot of the Unit Owners, a Board of Directors in accordance with the requirements of Section 5 of Article V of these By-Laws. The Council may also transact such other business of the condominium as may properly come before them.

It is the intention that all the other provisions of the Declaration shall remain in full force and effect as therein more particularly set out.
