LOCATION:

4115 6th Street is located in the Brooklyn neighborhood of South Baltimore City. The community was shaped by the shipping industries surrounding it and has the advantages of living in a large metropolitan city with the comfort of a small town. The property is approximately 0.4 mile away from E. Patapsco Avenue, which conveniently features retail, dining and entertainment options. Close by on Ritchie Highway are a Lidl Supermarket (1.6 miles) and the Enoch Pratt Free Library (0.7 mile). Major employers in the area include MedStar Harbor Hospital (2 miles) and the Maryland Cruise Terminal (5 miles), in addition to local industrial jobs within the community. Brooklyn provides commuters easy and convenient access to major highways, including I-95 (3 miles), I-695 (2.4 miles) and I-895 (0.8 mile).
