LOCATION:

2402 Pleasantville Road, known as Acapella Italian Restaurant, is located in the Fallston area in Harford County. Located near the intersection of Fallston Road (MD-152), the site affords a convenient location for those consumers who live nearby, in addition to those visiting the area. Traffic along Pleasantville Road in front of the site is 4,834 cars per day (AADT), with another 22,434 cars per day passing along Fallston Road at the intersection of Pleasantville Road. The sprawling Fallston Recreation Complex is a short distance to the south, providing a ready source of traffic in the area. Nearby schools, religious facilities and retail businesses, including Walgreen's across the street and 7-Eleven next door, provide additional sources of exposure at the site. A significant amount of residential subdivisions are in the immediate area, in addition to those farms, farmettes and wooded tracts for which Harford County is known.

Acapella is a well-known Italian eatery in the area, featuring lunch and dinner service, catering and hosted events. The restaurant boasts a 4.4 star rating on Google among 475 reviews, many of which rave about the excellent pizza and service. The restaurant has been located at the site for nearly 10 years, and has been both a community favorite and destination location throughout that time.

LOCATION (continued):

The auction provides an opportunity to purchase a stabilized investment with an asset that is exceedingly welldemanded in the area. There is a low density of retail investments in much of Harford County, notably outside of Bel Air and Edgewood, making the site a rarely available investment opportunity. A good rental history, good product and limited availability should make the site attractive for investors of all types.

IMPROVEMENTS:

Restaurant building – constructed in 1974 and containing 2,976 square feet of gross building area, according to public tax records. Commercial listing services put the building area at 3,401 square feet. The building underwent a comprehensive renovation in conjunction with the current occupant. Features include an ornate Italian villa inspired facade, full dining room, bar, outdoor patio, commercial kitchen, walk-in storage, office and restrooms. Finishes are predominately ceramic tile floors, drywall and acoustic tile ceilings.

Acapella has occupied the site since January 1, 2014. The current lease rate is \$54,648 per year, NNN, through December 31, 2023. The tenant has exercised one of two remaining 5 year extensions, with the rent increasing to \$62,845.20 per year, NNN, from January 1, 2024 through December 31, 2028.

Live Auction Bidders – a 50,000 deposit, payable by cashier's check, will be required of the purchaser at time and place of sale. The deposit shall be increased to 10% of the purchase price within 24 hours at the Auctioneer's office (wire or cashier's check).

Online Auction Bidders – a \$50,000 deposit, payable by cashier's check or wire, will be required of all online bidders prior to the start of the live auction. The deposit will be held in escrow until the completion of the auction and will be retained from the winning bidder. Other bidder deposits will be returned within one business day. - 6. After completing the registration steps, you will be redirected to the online bidding screen.

INSTRUCTIONS FOR ONLINE BIDDING

- The online bidding screen will display information such as time left in the auction, starting bid, and your personal max bid (if you have placed a max bid). Once bidding has started, there is a tab for bids which will show all the bids that have been placed.
- 2. To place a new bid, click the red button which displays the current asking amount.
- 3. To bid a custom amount, click the arrow at the right of the bid button and choose: Bid a specific amount.

PURCHASING REAL ESTATE AT AUCTION

The following information is provided by A. J. Billig & Co., Auctioneers to assist you in understanding your purchase of a property at public auction. The material in this form is general in nature and does not limit your obligations under the contract of sale that you will be required to sign.

TERMS OF SALE: Your responsibilities as a purchaser have been advertised prior to the day of sale and will be read by the Auctioneer at the time of sale. Additional terms may be announced on the day of sale or may be posted at the sale site. The auctioneer will make important announcements regarding the property and your obligations as a purchaser. Please feel free to ask any questions regarding these terms. *Failure to comply with any of the terms of sale may cause you to forfeit your deposit and be responsible for the expenses to resell the property, as well as any deficiency incurred.*

CONDITION OF PROPERTY: The property will be sold "AS IS." Unless otherwise announced, the sellers make no representations or warranties about the condition of the property. The sellers will not make any repairs.

DEPOSIT: Your deposit will be credited toward the purchase price. If you do not comply with the "TERMS OF SALE," either published or within the contract of sale, you might lose all or part of your deposit. In addition, if you fail to settle for the property you might be obligated to pay the expenses to resell the property, including any deficiency resulting therefrom. If the "TERMS OF SALE" require you to increase your deposit above the amount specified, the Auctioneer will likely accept your personal or business check for the difference on the day of sale. Otherwise, you can bring, wire or messenger certified funds for the increased deposit within the time stated.

EXPENSES: You may be responsible for the expenses of owning the property as of the date of sale or as of the date of settlement, including taxes, utility costs and insurance. You may be required to pay interest on the amount of the purchase price, less the amount of your deposit, from the date of the sale to the date you settle for the property. We recommend that you obtain a fire insurance binder on the property immediately as of the date of sale. The purchaser will pay all of the settlement expenses, including title fees and recording costs.

SETTLEMENT: The settlement or closing period is specified within the terms of sale. If settlement is based on ratification by a Court, the ratification period is typically forty-five to sixty days, but might take longer. You will be expected to settle for the property within the specified time.

FINANCING: It is the purchaser's responsibility to obtain financing. If you plan to use a mortgage to purchase the property, we recommend that you apply for the loan immediately. If the bank must take longer than the specified time to complete the loan, the sellers may extend settlement for a short period if you can provide proof of a loan commitment. If you do not obtain the financing within the specified time for settlement, you will be in default of your contract of sale.

BIDDING PROCEDURE: At the conclusion of the announcement and question period, the auctioneer will solicit bids for the property. Bids are generally made either orally or by raising a hand. Bidding increments are made in amounts acceptable to the auctioneer, who may set a minimum bidding increment as the sale progresses. Any bid that is merely a nominal or fractional advance may be rejected by the auctioneer if in his judgement it may affect the sale injuriously. If a dispute arises between two or more bidders, the auctioneer shall decide in favor of one of the bidders, or immediately re-offer the property.
