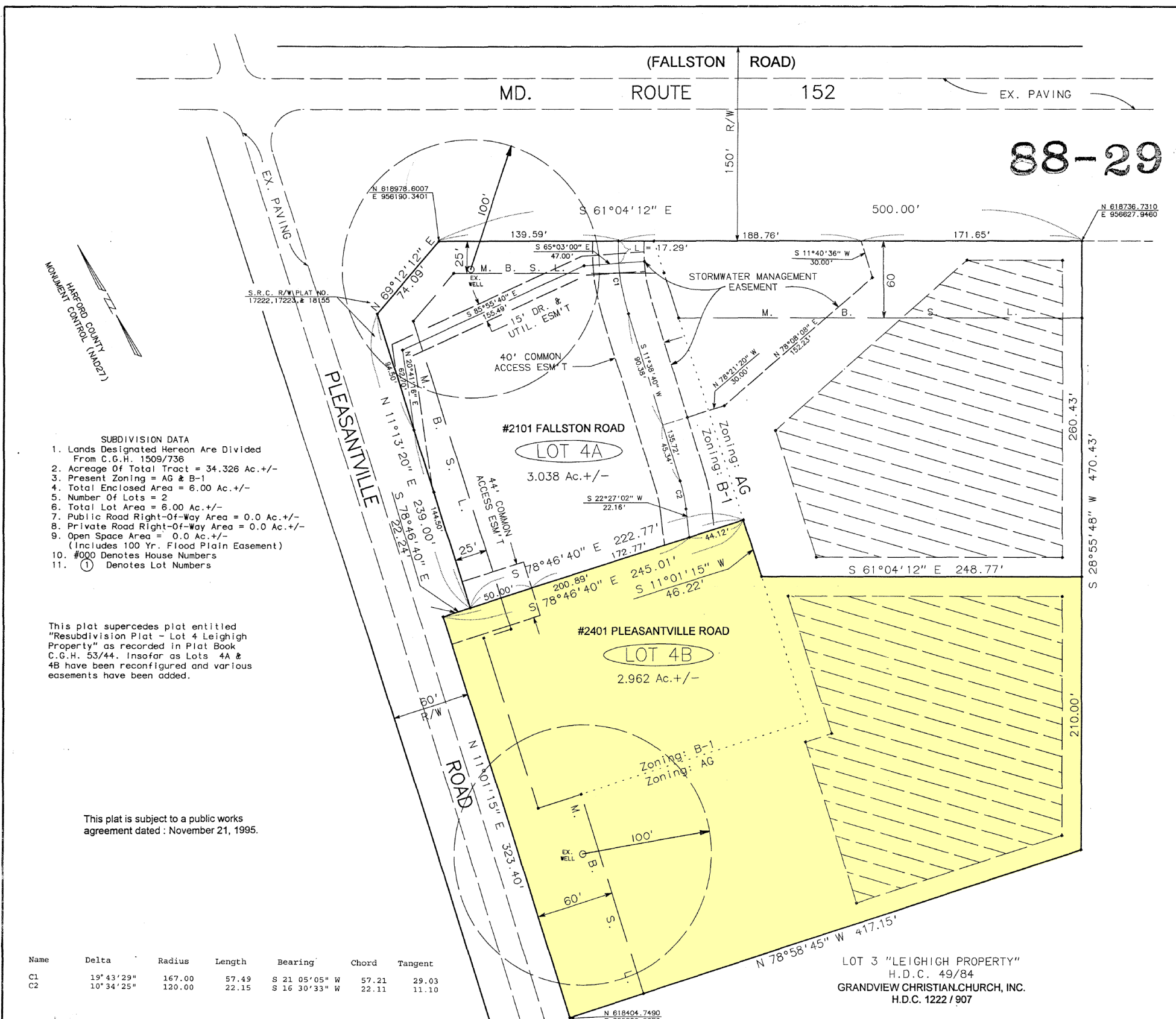


LOCATION MAP

- THIS SUBDIVISION MUST COMPLY WITH STATE REGULATIONS FOR UNDERGROUND ELECTRIC DISTRIBUTION AND TELEPHONE SERVICES.
  - DRIVEWAY ENTRANCE CONSTRUCTION AND LOCATION TO BE APPROVED BY HARFORD CO. DEPT. OF PUBLIC WORKS AND/OR THE STATE HIGHWAY ADMINISTRATION.
  - LOTS CREATED AFTER 8-FEB-77.
  - SEPTIC SYSTEM OR WELL REQUIREMENTS BECOME NULL AND VOID WHEN PUBLIC WATER OR SEWERAGE ARE PROVIDED TO THE LOT.
  - GROUND WATER APPROPRIATION PERMIT NO. HA 84 GAP 001
  - WELLS SHOWN HEREON EXISTING.
- A WELL SHALL BE DRILLED AND SHALL BE APPROVED BY THE HARFORD CO. HEALTH DEPARTMENT PRIOR TO ISSUANCE OF A BUILDING PERMIT.
  - SEPTIC RESERVE AREA DENOTES THE 40,000 SQ. FT. WASTE DISPOSAL AREA. NO CONSTRUCTION IS PERMITTED IN THE DESIGNATED AREA. NO CONSTRUCTION WITHIN 30 FEET OF THE WASTE DISPOSAL SYSTEM AREA WITHOUT PERMIT APPROVAL OF THE COUNTY HEALTH DEPT. EXCEPTIONS UP TO WASTE DISPOSAL AREA, BUT NOT WITHIN IT ARE PERMITTED FOR DRIVEWAYS, UTILITIES, AND SMALL PHYSICAL STRUCTURES (TOOL SHEDS, ETC.)
