LOCATION:

100 & 110 Fuller Avenue are located in the Fullerton area of northeastern Baltimore County, west of the 7300 block of Belair Road. The surrounding neighborhood is a mixture of detached homes and townhomes. Fuller Avenue is a cul de sac, one block south of the Taylor Park Playground. Nearby public schools are Fullerton Elementary, Parkville Middle and Parkville High, according to the Baltimore County government website. Shopping and public transportation are two blocks east of the property along Belair Road. The Baltimore Beltway (I-695) is one-half mile to the north, providing good access to employment centers throughout the region. According to Bright MLS, property sales in the immediate neighborhood have ranged from \$240,000 to \$419,000, in the last twelve months.

110 FULLER AVENUE:

Stucco Bungalow, built in 1928, containing approximately 720 square feet of first floor living area, unfinished attic of approximately 360 square feet and basement of 720 square feet, according to public tax records. *The property is vacant and available for viewing.* Lot size 45' x 142' or 0.147 acre. In fee simple. Zoning DR 5.5, residential. Public utilities.

The property has a 3-car concrete driveway and fenced rear yard. Exterior of the home has a covered front porch, wheelchair ramp in rear, vinyl-clad double-hung windows and composition shingle roof. Wood floors throughout.

First floor has a living room, dining room, kitchen with gas range/oven, refrigerator, laminate cabinets and counters, two bedrooms and full bath. Walk-up attic, unfinished. Full, partially finished basement. Gas forced air heat and central air conditioning, gas water heater and 100 amp. electrical service. *The home needs updating and cosmetic repairs.*

Lease; Letter To Vacate. Lot size 46' x 142' or 0.15 acre. In fee simple. Zoning DR 5.5, residential. Public utilities.

The property has a 3-car asphalt driveway and fenced rear yard. Exterior of the home has a covered front porch, vinyl-clad doublehung windows and composition shingle roof. Wood floors throughout.





<u>Live Auction Bidders</u> – A \$10,000 deposit on each property, payable by cashier's check, will be required of the purchaser at time and place of sale. If necessitated by price, the deposit shall be increased to 10% of the purchase price within 24 hours at the Auctioneer's office (company or personal checks for the increased deposit will be accepted at the sale site or wiring instructions will be provided).

<u>Online Auction Bidders</u> – A 10% deposit on each property, payable by wire transfer or cashier's check, is required by 4:00 p.m. on the day of auction. No exceptions.

Deposit funds shall be held by A. J. Billig & Co., LLC. Balance to be paid in cash at settlement, which shall take place within 45 days. If payment of the deposit or balance does not take place within the specified time, the deposit shall be forfeited and the property may be resold at the risk and expense of the purchaser. Interest to be charged on the unpaid purchase money, at the rate of 12% per annum, from date of contract to date of settlement. PURCHASING REAL ESTATE AT AUCTION

The following information is provided by A. J. Billig & Co., Auctioneers to assist you in understanding your purchase of a property at public auction. The material in this form is general in nature and does not limit your obligations under the contract of sale that you will be required to sign.

TERMS OF SALE: Your responsibilities as a purchaser have been advertised prior to the day of sale and will be read by the Auctioneer at the time of sale. Additional terms may be announced on the day of sale or may be posted at the sale site. The auctioneer will make important announcements regarding the property and your obligations as a purchaser. Please feel free to ask any questions regarding these terms. *Failure to comply with any of the terms of sale may cause you to forfeit your deposit and be responsible for the expenses to resell the property, as well as any deficiency incurred.*

CONDITION OF PROPERTY: The property will be sold "AS IS." Unless otherwise announced, the sellers make no representations or warranties about the condition of the property. The sellers will not make any repairs.

DEPOSIT: Your deposit will be credited toward the purchase price. If you do not comply with the "TERMS OF SALE," either published or within the contract of sale, you might lose all or part of your deposit. In addition, if you fail to settle for the property you might be obligated to pay the expenses to resell the property, including any deficiency resulting therefrom. If the "TERMS OF SALE" require you to increase your deposit above the amount specified, the Auctioneer will likely accept your personal or business check for the difference on the day of sale. Otherwise, you can bring, wire or messenger certified funds for the increased deposit within the time stated.

EXPENSES: You may be responsible for the expenses of owning the property as of the date of sale or as of the date of settlement, including taxes, utility costs and insurance. You may be required to pay interest on the amount of the purchase price, less the amount of your deposit, from the date of the sale to the date you settle for the property. We recommend that you obtain a fire insurance binder on the property immediately as of the date of sale. The purchaser will pay all of the settlement expenses, including title fees and recording costs.

SETTLEMENT: The settlement or closing period is specified within the terms of sale. If settlement is based on ratification by a Court, the ratification period is typically forty-five to sixty days, but might take longer. You will be expected to settle for the property within the specified time.

FINANCING: It is the purchaser's responsibility to obtain financing. If you plan to use a mortgage to purchase the property, we recommend that you apply for the loan immediately. If the bank must take longer than the specified time to complete the loan, the sellers may extend settlement for a short period if you can provide proof of a loan commitment. If you do not obtain the financing within the specified time for settlement, you will be in default of your contract of sale.

BIDDING PROCEDURE: At the conclusion of the announcement and question period, the auctioneer will solicit bids for the property. Bids are generally made either orally or by raising a hand. Bidding increments are made in amounts acceptable to the auctioneer, who may set a minimum bidding increment as the sale progresses. Any bid that is merely a nominal or fractional advance may be rejected by the auctioneer if in his judgement it may affect the sale injuriously. If a dispute arises between two or more bidders, the auctioneer shall decide in favor of one of the bidders, or immediately re-offer the property.

INSTRUCTIONS	FOR ONLINE	AUCTIONS

REGISTERING TO BID

- 1. Go to ajbillig.com/auctions and find the web page for the auction you are interested in.
- 2. Click the button: Register & Bid Online.
- 3. After the online bidding screen opens, click the button: Register To Bid a. If you don't have an account, click: "NO ACCOUNT? SIGN UP HERE"

b. If you already have an account, enter your login information.

- 4. Enter your contact information and agree to the terms of sale and terms of use.
- 5. Enter your credit card* information to confirm your identity. You will NOT be charged the deposit amount.
- 6. After completing the registration steps, you will be redirected to the online bidding screen.

INSTRUCTIONS FOR ONLINE BIDDING

- The online bidding screen will display information such as time left in the auction, starting bid, and your personal max bid (if you have placed a max bid). Once bidding has started, there is a tab for bids which will show all the bids that have been placed.
- 2. To place a new bid, click the red button which displays the current asking amount.
- 3. To bid a custom amount, click the arrow at the right of the bid button and choose: Bid a specific amount.
- 4. Once a bid amount is entered, the system will prompt you to confirm the amount that you offered. Click Confirm Bid to place your bid.
- 5. To place a max bid before the auction begins, click on the prebid button and enter the maximum amount that you plan on offering for the property. The system will autobid for you up to that point. If you would like to place a max bid while the auction is live, click the arrow at the right of the bid button and choose: Create maxbid.
- 6. A.J. Billig will send out reminders regarding time left in the auction and other pertinent information. The menu icon on the top right of the screen will display the message board where all of the notifications will be sent.
