#### **GENERAL INFORMATION:**

Triple net ground lease to Sheetz, Inc., originally dated October 18, 2002 and as amended by subsequent addenda. The lease is in a five-year extension period, running through April 30, 2028, with an annual rent of \$225,480 NNN. There are 6 remaining five-year options at 10% per period increased base rent. The extension beginning May 1, 2028 has an annual rent of \$248,028 NNN. Tenant pays for all maintenance, insurance and annual real estate taxes.

#### LOCATION:

The property is situated in the West York area of York County, Pennsylvania. The property is located at the signalized intersection of West Market Street (US-30), North Baker Road and Trinity Road (PA-616). Traffic counts (AADT) at the intersection are 19,790 cars per day along West Market Street and 9,871 along Trinity Road. West Market Street merges with US-30 a short distance east of the property, providing a confluence of traffic coming from the Greater York region. The property is strategically positioned among a number of large corporations and employers in the immediate area, including Goodyear, DHL, FedEx, Frito-Lay, Vulcan Materials, Kinsley Materials, A&S Kinard and Georgia Pacific, each of which provide dedicated, regular traffic to and from the area. A number of residential subdivisions, recreational facilities and agricultural operations are also in the surrounding location.







#### **IMPROVEMENTS:**

Freestanding masonry convenience store building, fuel island and car wash. The primary building was originally constructed in 2002 and expanded in 2023 to contain 6,128 square feet of gross building area, according to public tax records. Car wash contains 936 square feet of gross building area. The fuel islands consist of 5 two-sided pumps (10 fueling stations) with covered awning.

#### <u>SITE:</u>

2.6 acres, more or less

Concrete and asphalt paved with parking for 38+ vehicles. Public water and sewer.

Zoning CS – Commercial Shopping – According to the West Manchester Township zoning code, "The purpose of this district is to accommodate the everyday commercial needs of the Township's residents. The areas designated for this zone are characterized by a majority of converted residences along Carlisle Road, Richland Avenue and West Market Street. Consequently, flexible design standards have been imposed to facilitate the preservation of converted residences. Overall retail size has been limited to prevent large-scale commercial uses that would be too intensive for adjoining residential neighborhoods."

#### TITLE:

The property is in fee simple and sold free and clear of liens. York County Deed Book 1574, Page 0214, et seq.

#### TAXES:

Published annual real estate taxes are \$11,675.28, based on a full value assessment of \$1,279,240, plus a school tax of \$44,027.46 per year and a \$45 annual fee to West Manchester Street Light authority. The taxes are paid by the tenant.

## **PURCHASING REAL ESTATE AT AUCTION**

The following information is provided by A. J. Billig & Co., Auctioneers to assist you in understanding your purchase of a property at public auction. The material in this form is general in nature and does not limit your obligations under the contract of sale that you will be required to sign.

**TERMS OF SALE:** Your responsibilities as a purchaser have been advertised prior to the day of sale and will be read by the Auctioneer at the time of sale. Additional terms may be announced on the day of sale or may be posted at the sale site. The auctioneer will make important announcements regarding the property and your obligations as a purchaser. Please feel free to ask any questions regarding these terms. *Failure to comply with any of the terms of sale may cause you to forfeit your deposit and be responsible for the expenses to resell the property, as well as any deficiency incurred.* 

**CONDITION OF PROPERTY:** The property will be sold "AS IS." Unless otherwise announced, the sellers make no representations or warranties about the condition of the property. The sellers will not make any repairs.

**DEPOSIT:** Your deposit will be credited toward the purchase price. If you do not comply with the "TERMS OF SALE," either published or within the contract of sale, you might lose all or part of your deposit. ## **REGISTERING TO BID**

- 1. Go to ajbillig.com/auctions and find the web page for the auction you are interested in.
- 2. Click the button: Register & Bid Online.

- 6. After completing the registration steps, you will be redirected to the online bidding screen.

## **INSTRUCTIONS FOR ONLINE BIDDING**

- The online bidding screen will display information such as time left in the auction, starting bid, and your personal max bid (if you have placed a max bid). Once bidding has started, there is a tab for bids which will show all the bids that have been placed.
- 2. To place a new bid, click the red button which displays the current asking amount.
- 3. To bid a custom amount, click the arrow at the right of the bid button and choose: Bid a specific amount.
- 4. Once a bid amount is entered, the system will prompt you to confirm the amount that you offered. Click Confirm Bid to place your bid.
- 5. To place a max bid before the auction begins, click on the prebid button and enter the maximum amount that you plan on offering for the property. The system will autobid for you up to that point. If you would like to place a max bid while the auction is live, click the arrow at the right of the bid button and choose: Create maxbid.
