

GENERAL INFORMATION:

1301 Roland Heights Avenue comprises a religious building on 0.32 acre in the Medfield neighborhood of North Baltimore. Medfield is ideally situated among some of Baltimore's most demanded and steadily developing neighborhoods, including Cross Keys, Roland Park, Hampden, Woodberry and the Mill projects throughout the Jones Falls Valley. The site has received significant development evaluation, with concept drawings and preliminary engineering plans for a multifamily building. The site is well positioned for either multi-family use, single family use or ongoing utilization as a religious facility. The auction provides an excellent opportunity to buy a well sized parcel with existing structure in a location that is highly sought after.

LOCATION:

¹301 Roland Heights Avenue, formerly known as the New Hope Church of God, is located at the intersections of Roland Heights Avenue and Newport Avenue in Medfield. Medfield is bound to the west by the Jones Falls Expressway and Jones Falls Valley, as well as the Woodberry Neighborhood, which contains many of Baltimore's television media companies, Loyola University Athletic facilities, Kennedy Krieger, and a number of trails and parks. Cross Keys is located to the north, and has been the subject of extensive new development over the past few years, including new restaurants, new retail stores and plans for new residential and commercial buildings. To the east is Hoes Heights, Roland Park, Keswick and both the Loyola and Johns Hopkins Universities. Hampden, perhaps the best known and visited neighborhood in North Baltimore, is to the south and home of The Avenue shopping district, newly renovated Rotunda mixed-use development, dozens of restaurants, retail storefronts and significant employers. Medfield itself is a quiet, residential community that has seen a good amount of new residential development over the past 10 years, including a few blocks west along Roland Heights Avenue. Nearby homes are a mix of single family detached, townhomes and apartments. Medfield Heights Elementary and Park is just one block west. TERMS OF SALE: Your responsibilities as a purchaser have been advertised prior to the day of sale and will be read by the Auctioneer at the time of sale. Additional terms may be announced on the day of sale or may be posted at the sale site. The auctioneer will make important announcements regarding the property and your obligations as a purchaser. Please feel free to ask any questions regarding these terms. *Failure to comply with any of the terms of sale may cause you to forfeit your deposit and be responsible for the expenses to resell the property, as well as any deficiency incurred.*

CONDITION OF PROPERTY: The property will be sold "AS IS." Unless otherwise announced, the sellers make no representations or warranties about the condition of the property. The sellers will not make any repairs.

DEPOSIT: Your deposit will be credited toward the purchase price. If you do not comply with the "TERMS OF SALE," either published or within the contract of sale, you might lose all or part of your deposit. In addition, if you fail to settle for the property you might be obligated to pay the expenses to resell the property, including any deficiency resulting therefrom. BIDDING PROCEDURE: At the conclusion of the announcement and question period, the auctioneer will solicit bids for the property. Bids are generally made either orally or by raising a hand. Bidding increments are made in amounts acceptable to the auctioneer, who may set a minimum bidding increment as the sale progresses. Any bid that is merely a nominal or fractional advance may be rejected by the auctioneer if in his judgement it may affect the sale injuriously. If a dispute arises between two or more bidders, the auctioneer shall decide in favor of one of the bidders, or immediately re-offer the property.

INSTRUCTIONS FOR ONLINE AUCTIONS

REGISTERING TO BID

- 1. Go to ajbillig.com/auctions and find the web page for the auction you are interested in.
- 2. Click the button: Register & Bid Online.
- 3. After the online bidding screen opens, click the button: Register To Bid a. If you don't have an account, click: "NO ACCOUNT? SIGN UP HERE"
 - b. If you already have an account, enter your login information.
- 4. Enter your contact information and agree to the terms of sale and terms of use.
- 5. Enter your credit card* information to confirm your identity. You will NOT be charged the deposit amount.
- 6. After completing the registration steps, you will be redirected to the online bidding screen.

INSTRUCTIONS FOR ONLINE BIDDING

- The online bidding screen will display information such as time left in the auction, starting bid, and your personal max bid (if you have placed a max bid). Once bidding has started, there is a tab for bids which will show all the bids that have been placed.
- 2. To place a new bid, click the red button which displays the current asking amount.
- 3. To bid a custom amount, click the arrow at the right of the bid button and choose: Bid a specific amount.
- 4. Once a bid amount is entered, the system will prompt you to confirm the amount that you offered. Click Confirm Bid to place your bid.
- 5. To place a max bid before the auction begins, click on the prebid button and enter the maximum amount that you plan on offering for the property. The system will autobid for you up to that point. If you would like to place a max bid while the auction is live, click the arrow at the right of the bid button and choose: Create maxbid.
- 6. A.J. Billig will send out reminders regarding time left in the auction and other pertinent information. The menu icon on the top right of the screen will display the message board where all of the notifications will be sent.
