

GENERAL INFORMATION:

A large income producing commercial storefront building will be offered for auction. The building formerly consisted of three tax records, since merged into one. 5109 Park Heights Avenue is leased to a restaurant for \$1,950 per month, on a month-to-month lease. The first floor of 5111-5113 Park Heights Avenue is in shell condition. The second floor of all buildings are connected and requiring renovation. A portion of the roof is leased to a billboard company for \$750 per month, through December 31, 2025 and continues month to month thereafter. Investors can develop a commercial building in a Northwest Baltimore Opportunity Zone with existing monthly income.

LOCATION:

5109 Park Heights Avenue is located in the Central Park Heights neighborhood in northwest Baltimore. World famous Pimlico Race Course, home of the Preakness, is less than one block away. Other surrounding neighborhoods include Cylburn, Levindale, Arlington and Pimlico Good Neighbors. Park Heights Avenue is among the busiest thoroughfares and commuter routes in the area, boasting 14,234 cars per day (AADT), according to MDOT statistics. Another 12,514 cars per day pass along W. Belvedere Avenue immediately north of the property. Surrounding properties are a mix of restaurants, retail storefronts, small offices, religious facilities and Pimlico itself. Sinai Hospital, another major employer in the area, is less than one mile east.

IMPROVEMENTS:

Three contiguous two story commercial buildings, constructed in 1937, containing 5,344 above grade square feet and 2,672 square feet of basement space, according to public tax records. 5109 Park Heights Avenue is used as a restaurant carry out. 5111 & 5113 Park Heights Avenue are vacant and arranged as a single unit with a large open layout. The second floor of all buildings are all interconnected. Renovation is required.

PURCHASING REAL ESTATE AT AUCTION

The following information is provided by A. J. Billig & Co., Auctioneers to assist you in understanding your purchase of a property at public auction. The material in this form is general in nature and does not limit your obligations under the contract of sale that you will be required to sign.

TERMS OF SALE: Your responsibilities as a purchaser have been advertised prior to the day of sale and will be read by the Auctioneer at the time of sale. Additional terms may be announced on the day of sale or may be posted at the sale site. The auctioneer will make important announcements regarding the property and your obligations as a purchaser. Please feel free to ask any questions regarding these terms. *Failure to comply with any of the terms of sale may cause you to forfeit your deposit and be responsible for the expenses to resell the property, as well as any deficiency incurred.*

CONDITION OF PROPERTY: The property will be sold "AS IS." Unless otherwise announced, the sellers make no representations or warranties about the condition of the property. The sellers will not make any repairs.

DEPOSIT: Your deposit will be credited toward the purchase price. If you do not comply with the "TERMS OF SALE," either published or within the contract of sale, you might lose all or part of your deposit. In addition, if you fail to settle for the property you might be obligated to pay the expenses to resell the property, including any deficiency resulting therefrom. Bidding increments are made in amounts acceptable to the auctioneer, who may set a minimum bidding increment as the sale progresses. Any bid that is merely a nominal or fractional advance may be rejected by the auctioneer if in his judgement it may affect the sale injuriously. If a dispute arises between two or more bidders, the auctioneer shall decide in favor of one of the bidders, or immediately re-offer the property.

REGISTERING TO BID

- 1. Go to ajbillig.com/auctions and find the web page for the auction you are interested in.
- 2. Click the button: Register & Bid Online.

- 5. Enter your credit card* information to confirm your identity. You will NOT be charged the deposit amount.
- 6. After completing the registration steps, you will be redirected to the online bidding screen.

INSTRUCTIONS FOR ONLINE BIDDING

- The online bidding screen will display information such as time left in the auction, starting bid, and your personal max bid (if you have placed a max bid). Once bidding has started, there is a tab for bids which will show all the bids that have been placed.
- 2. To place a new bid, click the red button which displays the current asking amount.
- 3. To bid a custom amount, click the arrow at the right of the bid button and choose: Bid a specific amount.
- 4. Once a bid amount is entered, the system will prompt you to confirm the amount that you offered. Click Confirm Bid to place your bid.
- 5. To place a max bid before the auction begins, click on the prebid button and enter the maximum amount that you plan on offering for the property. The system will autobid for you up to that point. If you would like to place a max bid while the auction is live, click the arrow at the right of the bid button and choose: Create maxbid.
- 6. A.J. Billig will send out reminders regarding time left in the auction and other pertinent information. The menu icon on the top right of the screen will display the message board where all of the notifications will be sent.
